1 Election Results:

1.1 Parish Council Election:

The Clerk reported that due to an uncontested election, the following Parish Councillors were duly elected on 4 May 2023: Sarah Beachell, Tony Corscadden, Sarah Duncan, Ben Jeffrey, Edward Staples.

1.2 Beverley Rural Ward Election:

The Clerk reported that the following Beverley Rural Ward Councillors were duly elected on 4 May 2023: Diana Stewart, Jeremy Wilcock, Paul Smith.

Jeremy Wilcock was welcomed to the meeting and he addressed those present, outlining the aspirations of the council. As ERYC was only due to meet the following day, he was unable to details any responsibilities but confirmed that he would be our Ward Councillor liaison.

The Clerk congratulated all on their election and to welcome those present to the meeting.

2 Election of Chair for 2023-24:

The Clerk accepted nominations for the role of Chair: BJ nominated and SD seconded SB for the role. SB accepted the nomination and was duly elected as Chair. The Clerk handed over the running of the meeting to The Chair.
